§1

1. The Lessor provides to the Lessee for use, a [Car Make and Model]..... ,
registration number. , VIN
number..... ,
on the terms specified in this agreement.
2. The vehicle is fully operational and has been inspected by both the Lessor and the Lessee.
3. The Lessee acknowledges having reviewed and accepted the General Car Rental Terms and Conditions - Appendix No. 1,
as well as the Consent to Personal Data Processing - Appendix No. 2, on the terms defined in this agreement.

§2

1. The agreement is entered into for a fixed period, i.e., from at to at

2. The daily lease rate of the vehicle is PLN gross.
3. The total lease price amounts to PLN gross.
In words
4. Payment is made in advance based on the lease agreement issued by the Lessor.
5. On the day of the vehicle handover, the Lessee is obliged to pay a deposit of PLN.

§3

1. In the event of damage to or loss of the vehicle due to the fault of the Lessee, the Lessee is obliged to immediately notify the Lessor of the incident.
2. If the damage occurs as a result of a road collision caused by third parties, the Lessee is obligated to contact the Lessor as soon as possible, notify the Police, obtain a statement from the perpetrator, and secure the vehicle.
3. The Lessee's contribution in damages caused by their fault amounts to a maximum of PLN.

§4

1. The Lessee agrees to full liability and to cover any damages resulting from operating the vehicle while under the influence of alcohol, narcotics, or pharmacological substances that prevent legal driving.
2. The maximum permitted driving speed of the car is 150 km/h. Frequent exceeding of the permitted speed (not applicable in necessary situations endangering the health and life of the driver and passengers) will result in the loss of the deposit.
3. Smoking tobacco is strictly prohibited in the car.

§5

1. In case of non-compliance with the terms of this agreement and the creation of an obligation on the part of the Lessee, the Lessee shall bear the costs of debt collection conducted by a Law Office hired by the Lessor.
2. In matters not regulated by this agreement, the relevant provisions of the Civil Code shall apply.
3. The court competent to settle any disputes arising from this agreement shall be the court competent by the location of the Lessor's registered office.
4. This agreement is made in two identical copies, one for each Party.
5. The Parties declare that they accept the terms of this agreement, raise no objections to its provisions, and sign it willingly.
